Objectives

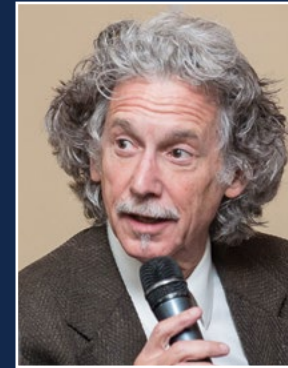
